Membership / Payment Rules

Payment of Subscription fees current season:	All members shall be required to pay a minimum of \$70.00 toward the current season's subscription or an automatic payment is established before the season starts or the player will not be eligible to play. All current season subscriptions need to be paid in full by the end of the season.			
	Failure to comply with the rules of payment of subscription fees will result in the member being deemed ineligible to play by default and the Club reserves the right to:			
	a) Withdraw the member in default from the team lists until payment has been made in accordance with the rules of payment,			
	b) Withdraw the team of the member in default from competition.			
	Payment of subs will be accepted on Thursday evenings after training or at other times when the payment facilities are available.			
	If paying in cash, this must be given to James Wombwell (treasurer) who will issue a receipt.			
	Fees include an old blues Polo shirt which must be worn on match days. (\$5.00 fine will be issued to all players who do not wear the club shirt on match days.)			
Subs in arrears:	Any member who is in arrears for subscriptions from previous seasons is required to pay all such arrears no later than seven(7) days prior to the first match day of the new (2016) season.			

Judicial:	If I infringe the laws of the game, I agree to pay all cost relating to that infringement. All infringements (yellow/Red Cards) must be paid within 7 days of any infringement.
	Late payment of infringement bills will result in an administration charge of \$ 2 per month.
	Note: Infringement cost may be waived at the discretion of the Tauranga Old Blues Committee.
